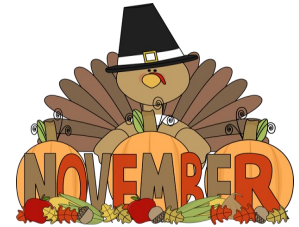

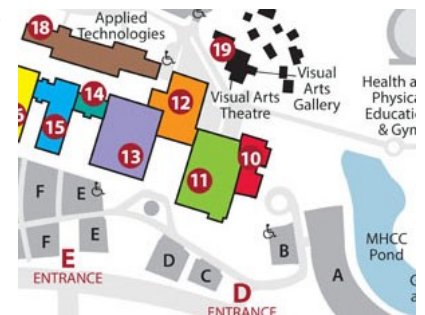


Hoodview's Facebook Page:

By Laws Change Proposal

Current Bylaws

SECTION 3. Nominating Committee

A. The Nominating Committee shall **submit a list of nominees** for each elective office of the Club, at the October Board meeting. Whenever possible more than one nominee shall be submitted for each elective office.

B. **Nominations** from the floor will open at the regular October and November meetings.

C. Each nomination by full members and/or the Nominating Committee shall have the approval of the nominee.

D. No nominations may be made at the time of the election.

E. The Nominating Committee **shall prepare printed ballots** for election of officers within seven (7) days after the close of nominations.

F. The Nominating Committee shall **distribute, collect and count ballots** received from all full members at the meeting wherein the election is held.

G. **Absentee ballots** shall be given, upon request, to all full members who are unable to attend the meeting at which the election is held. Request for absentee ballot must be made in sufficient time to allow for the return of the absentee ballot to the Nominating Committee prior to the election.

H. The following procedure will be followed **in the event an elected office becomes vacant** before the term expires:

1. In the event of a vacancy of an elected office, the Nominating Committee shall submit nomination(s) for the vacant office at the next general meeting following announcement of vacancy.
2. The floor will be open to any other nominations from the membership present and all nominations will be closed, voted on and elected by a majority of the members

New Bylaw Proposed

(Optional Procedures added to E, F, G, and may also be used for Section H as needed.)

I. Online or virtual voting *may be used* for annual elections of officers and board members. The processes or digital programs to be used is to be approved by the board. Once nominations have been finalized the online voting will be available for a minimum of 15 days prior to the December General meeting. Voting will close 30 minutes after the opening of the December General meeting.

WB7QIW—Help Wanted for Online-Tech Meeting

Two or three members who can regularly attend the club meeting to setup and run a club laptop, webcam, and hand out microphones. Any necessary training will be “on the job.” At the October Board Meeting, the board discussed improving online meetings. Online is important for a number of our members; some are home-bound, and it is difficult to get out, personal mobility and hearing is hard for some. Sometimes, attending virtually is an advantage. Without online meetings, some members would be shut out of the club.

The board discussed needing better and updated equipment, and we agreed that it would be worthwhile. But we realized that if we got the equipment, it would be a burden if we didn’t also have the people to run it. We need a lead person (chairmen of the Tech-Online Committee) to be primary point of contact with one or two backup people to help, and to cover when the lead person isn’t available.

The plan would be to start with what we have and to learn what we need to do. Then to identify and get additional equipment to improve video and audio. Also to use WebEx features to improve production as it seems appropriate.

End result would be online and local meetings will be integrated, everyone will have choices available, and everyone in the club can attend the meeting, if they wish.

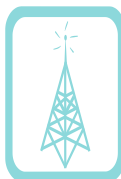
Check into the Hoodview Nets:
